What services and products do we offer you?

How do we charge for our services?

We arrange the policy with your selected provider on your behalf. You do not pay us a fee for doing this, however we do receive commission from the provider which varies and is either a percentage of the policy's premium or a fixed amount. If you are introduced to Protect My People by any third party, we may pay them an introducer fee from the commission we receive.

Who regulates us?
