What services and products do we offer you?

We are an online insurance intermediary comparing Group Life Insurance quotes for small and medium sized businesses from a panel of life insurance providers listed in Appendix A below.

To keep our costs down and deliver lower premiums to you, our service is online and we enable you to transact via our website and email. We provide customer services via email and phone

How do we help you select a product?

You will need to make your own product selection. We do not provide advice or a personal recommendation.

To assist you we ask questions to narrow down the selection of products that we will provide details on. You will then need to make your own choice about how to proceed.

How do we charge for our services?

We arrange the policy with your selected insurer on your behalf. You do not pay us a fee for doing this, however we do receive commission from the insurer which varies and is either a percentage of the policy's premium or a fixed amount. If you are introduced to ProtectMyPeople by any third party, we may pay them an introducer fee from the commission we receive.

Who regulates us?

Investment Discounts On Line Ltd is authorised and regulated by the Financial Conduct Authority (FCA). The FCA is the independent watchdog that regulates financial services. Our FCA Register number is 197451.
